1.1 PROJECT INFORMATION

- A. Notice to Bidders: Qualified bidders may submit bids for project as described in this Document. Submit bids according to the Instructions to Bidders.
 - 1. Regulatory Requirements: All Federal, State, and local laws shall govern submittal, opening, and award of bids.
- B. Project Identification: Plaquemines Parish Harbor & Terminal District – Pointe a la Hache (PALH) Rock Berm Construction & Ferry Landings Repair
 - 1. Project Location (West) : Westbank Pointe a la Hache Ferry Landing
 - 2. Project Location (East) : Eastbank Pointe a la Hache Ferry Landing

- A. Project Description: Project consists of The Work of Project, as defined by the Contract Documents and includes the following:
 - 1. Installation of a rock berm with recommended location and shape on the Westbank Landing.
 - 2. Towing, inspection, and repairs of the Westbank Ferry Barge.
 - 3. Repair the upper portion of the timber piles and the pile caps on both landings.
 - 4. Fabrication of steel truss bridge as indicated on drawings.
 - 5. Replacement of the steel truss bridge with similar truss bridge.
 - 6. Replacement of a portion of the towers' steel.
 - 7. Replacement of the tower access ladders.
- B. Construction Contract: Bids will be received for the following Work:
 - 1. General Contract (all trades).

1.2 BID SUBMITTAL AND OPENING

- A. Owner will receive sealed lump sum bids until the bid time and date at the location given below. Owner will consider bids prepared in compliance with the Instructions to Bidders issued by Owner, and delivered as follows:

1.3 BID SECURITY

- A. Bid security shall be submitted with each bid in the amount of 5 percent of the bid amount. No bids may be withdrawn for a period of 60 days after opening of bids. Owner reserves the right to reject any and all bids and to waive informalities and irregularities.

1.4 PREBID MEETING

- A. Prebid Meeting: A Prebid meeting for all bidders will be held at Plaquemines Port Harbor & Terminal District on 5/16/2024 at 10 a.m., local time. A **required site visit** will follow thereafter. Prospective prime bidders are **required** to attend.
